



EQUAL EMPLOYMENT OPPORTUNITY POLICY STATEMENT

It is Solid Sealing Technology, Inc.'s policy not to discriminate against any employee or applicant for employment because of his or her race, color, religion, sex, or national origin or because he or she is an individual with a disability or disabled veteran, Armed Forces service medal veteran, recently separated veteran, or active duty wartime or campaign badge veteran, or thereafter referred collectively as "protected veterans" or any other characteristics protected under applicable law. Further, Solid Sealing Technology will not discharge or in any other manner discriminate against employees or applicants because they have inquired about, discussed, or disclosed their own pay or the pay of another employee or applicant.

As President of Solid Sealing Technology, I am committed to the principles of Affirmative Action and Equal Employment Opportunity. In order to ensure dissemination and implementation of equal employment opportunity and affirmative action throughout all levels, I have selected Juliana Spath as the Human Resources Manager for Solid Sealing Technology.
